Baseline: Ever taught to recognize early symptoms, 57.7%, ever taught what to do during an asthma episode or attack, 67.6%, ever taught how to use a peak flow, 33.8, ever given an asthma action plan, 19.5%, ever taken a course to manage asthma, 5.2%.
